Release of Liability and Hold Harmless Agreement
PLEASE READ CAREFULLY

TO: EXTREME STABLES (the "OPERATOR") and its Directors, Trustees, agents, representatives, employees, volunteers, independent contractors, subcontractors, sponsors, successors and assigns (collectively the "RELEASEES")

DEFINITIONS: In this Agreement, the term "equestrian activities" shall include all activities, programs, events and services provided, sponsored, organized or hosted by the Operator including but not limited to: jumping, flat riding, lounging, hand walking, driving, and any and all other forms of mounted and un-mounted equestrian activities; use of equipment and facilities as provided by the Operator, including but not limited to jumping equipment, dressage fences, and riding arenas.

ASSUMPTION OF RISKS

I am aware that my participation in equestrian activities involves many risks, dangers, & hazards, which could result in damage, loss or physical injury to me, as well as damage or injury to animals owned by me. Some of these risks, dangers & hazards include but are not limited to:

- Health: the risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist
- Premises: defective, dangerous or unsafe condition of the facilities, falls, collisions with objects, equipment or persons
- Use of Equipment: mechanical failure of the equipment; negligent design or manufacture of the equipment; the provision of or the failure by the Releasees to provide any warnings, directions, instructions or guidance as to the use of the equipment, failure to use or operate the equipment within the equipment operator's own ability
- Advice: negligent advice regarding equestrian activities
- Operator's conduct and conduct of other persons; I acknowledge that such conduct, including my negligence & negligence of other persons, including NEGLIGENCE ON THE PART OF THE RELEASEES, may increase the risk of damage, loss, personal injury or death. I understand that the Releasees may fail to safeguard or protect me from the risk dangers & hazards of equestrian activities, some of which are referred to above.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Releasees, allowing me to participate in equestrian activities, use its equipment and facilities and providing its equine services and consultation, I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against THE RELEASEES AND TO RELEASE THE RELEASEES from any and all liability for any loss, damage, expense or injury including death that I may suffer or that my next-of-kin may suffer as a result of my participation in equestrian activities DUE TO ANY CAUSE WHATSOEVER, including but not limited to:
 - Negligence on the part of the Releasees;
 - Failure on the part of the Releasees to safeguard or protect me from the risks, dangers and hazards of equestrian activities, some of which are referred to in the Assumption of Risks section of this Agreement.
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damage, loss, expense or injury to any third party resulting from my participation in equestrian activities.
3. TO ADHERE TO THE posted STABLE rules. I agree that myself and my guests/invitees will be bound and abide by these Rules and accept responsibility for the conduct of my guests/invitees according to these Rules.

Despite the risks, dangers and hazards of equestrian activities, and fully understanding such risks, dangers and hazards, I wish to participate in equestrian activities with the Operator, and I FREELY ACCEPT AND FULLY ASSUME all such risks, dangers and hazards and the possibility of personal injury, death, property damage and loss resulting there from.

This Agreement shall be effective & binding upon my heirs, next-of-kin, executors, administrators, assigns & representatives, in the event of my death or incapacity.

INSURANCE: I am aware that the Releasees do not provide me with any disability, accident, liability or medical insurance or compensation, should I become injured or cause personal injury or property damage to any third party while participating in equestrian activities. (If rider is 18 years of age or over)

JURISDICTION: This Agreement and any rights, duties and obligation as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the Province of Alberta, and I agree to attorn solely to the jurisdiction of the Courts of The Province of Alberta. Any litigation involving the parties to this Agreement shall be brought solely within the Province of Alberta and shall be within the exclusive jurisdiction of the Courts of the Province of Alberta.

Extreme Stables and Tack - Dressage Schooling & Jumper Show Regulations

1. All entry communication will be done via Email.
2. Riders may enter up to four (4) classes in (2) consecutive jumper divisions or two (2) consecutive jumper divisions per day plus any number of fun classes (❖) that correspond to the divisions entered.
3. Riders may not ride in the Beginner Classes (Classes 24 to 27 and 36 to 38) and Regular Classes (Classes 28 to 35 and 39 to 45) on the same day.
4. Jumper classes may be scheduled on the grass or sand rings.
5. Dressage Tests – All Dressage Tests are new in 2023. We will be using the most current versions.
6. Table A – Jumping faults for each disobedience will be accumulated.
7. Table C – Jumping Faults for each disobedience will be accumulated in seconds added to time taken to complete round.
8. Power and Speed – First half of the course is the “power” portion of the class, if it is jumped clear, then the rider will continue with the second half of the course which will be timed, the “speed” portion. If there are any faults in the power portion of the course, the jump judge may signal the rider to exit the ring without continuing to the speed portion.
9. ❖ Three Bar Challenge – One warm up fence will be allowed before going down a line of 3 vertical jumps. After each rider has had a turn, each rider who has gone clear will continue to next round. Fences will be raised approximately 3" each round. The last rider to go clear will be the winner.
10. ❖ Ride and Run – A runner on foot completes the course ahead of a rider on horseback who cannot pass the runner. Team with the fastest combined time will be the winners.
11. ❖ Bareback \$5.00 Race – riders to ride their horses bareback with a \$5.00 bill placed by the judges under the rider's leg. When the bill is dropped the rider is out of the race. Last rider with their bill wins all the money dropped by all riders. Riders are to supply the \$5.00 bill.
12. Nations Cup – Teams of 3 or 4 riders; each rider to ride 2 rounds over different courses, top three scores of each round will be accumulated. A percentage of the entries collected will be paid to the top teams.
13. Lead Line – Riders must be 6 years and under, *MUST wear a Helmet*, and may not enter any other classes. Horse must have a halter and lead shank and be controlled by the handler. AEF Number is not required for this class. Lead Line classes will be run close to or during the Lunch Breaks.
14. Adult Champagne Class – Riders are to be parents of exhibitors and must wear an approved ASTM/SEI helmet and proper riding footwear with a minimum 1/2" heel. A handler may lead the horse with a halter and lead shank.
15. Saturday Fun Classes – tentative order of classes will be:
 - a. Costume
 - b. Bar-B-Que Supper
 - c. Barback \$5.00 Bill Race – bring your own \$5.00
 - d. Adult Champagne Race
 - e. 3 Bar Challenge
 - f. Ride & Run
16. Junior Exhibitors will be under 18 years as of January 1st of the current year; Senior Exhibitors will be 18 years and over as of January 1st of the current year.
17. EC/AEF Membership every rider must provide proof of either a provincial or national sport license or membership, or equivalent membership.
18. This show is run similar to the rules of the A.E.F. and E.C. It shall be the responsibility of each exhibitor to have full knowledge of the classes in which he/she is showing. Anyone not abiding by the rules may be disqualified. The decision of the Judge, Steward, and Show Committee is final.
19. This is not a recognized show and does not have all the amenities of such a show. I.e. show is run outdoors; seating is not supplied; wash racks are not available to exhibitors, be prepared to bucket-bath if bathing is required.
20. Stallions may only be exhibited by Senior Exhibitors.
21. Classes may be cancelled, combined, or further divided at the discretion of the Show Committee. The Show Committee has the option to limit entries or may cancel the show without notice.

22. Classes will be run in either the grass or sand ring at the discretion of the Show Committee. Be prepared to ride in either.
23. Hors Concours entries may be accepted at normal class fees if scheduling permits. Entrants are subject to show rules, and entries are not eligible for ribbons or awards.
24. Entries received after the August 6th Closing Date will be charged a \$21.00 Late fee.
25. Entries will not be considered complete until correct full payment has been received.
26. Any unsigned entries and waivers will be refused entry into the ring.
27. Cancellation of Entries and Refunds of Entry Fees: All cancellation and withdrawal requests must be submitted by email to FunHorseEvents@gmail.com.
 - a. If the cancellation request is received Before the August 5th, all fees less the Office Fee will be refunded.
 - b. If the request is received On or After August 6th and Before August 9th, A Veterinarian or Doctor's certificate is mandatory for a refund of stabling fees and 50% of the class fees. The Office Fees and the remaining 50% of the class fees will not be refunded.
 - c. Cancellation requests received After August 9th are not eligible for a refund under any circumstances.
28. NSF Cheques will be charged a \$31.50 fee.
29. Limited Stabling is available and will be designated at the discretion of Extreme Stables. Please indicate if multiple horses can be stabled together in pens/paddocks.
30. Stalls are to be cleaned before leaving. Shavings are available. Please show respect and use only as much as necessary.
31. Indoor Day Stalls are inside the barns and have VERY limited availability.
32. Outdoor Stalls are grouping of temporary stalls setup in the field near the show rings and parking. Outdoor stalls are uncovered, Shavings will be provided, and stall guards are not required.
33. Stalls for Exhibitors arriving Friday for Saturday classes will be available after 6:00 pm. Please plan to arrive after 6:00.
34. Cross entries. A horse may not be shown by more than one exhibitor per day. A Horse/Rider team may not show in both the Grass Ring and the Sand Ring on the same day. Classes in the Grass Ring and the Sand Ring run at the same time. It is the Exhibitor's responsibility to ensure they are ready to ride in their class.
35. Start Times for Jumper Days will be posted the evening before.
36. Inhumane treatment will not be tolerated, and unruly horses may be excused from the ring.
37. The Show Committee Members, Directors, or affiliates of the Show will NOT be held responsible or liable in any manner for any or all accident(s) or injury(s) to any person(s) of any extent including participant(s) of the show or spectator(s); damage or theft of any person(s) material or equipment or any other possessions owned, rented, or loaned to any person(s) who are on the premises where the Show is located for the duration of the Show.
38. Protests must be made to the Show Committee within 48 hours of the class and must be in writing and accompanied by \$250.00 cash.
39. Warm Up – the course will be open for one half hour prior to the start of the show day and will close 2 minutes before the first class. Warm up on the course will be available between each division for riders who have not competed in a previous division. Weather permitting; warm up fences will also be available in the warmup ring.
40. Please obey all posted signs. Washrooms in the barn are for Show Staff and Boarders only. Mobile washrooms are available at various locations around the grounds.
41. All Dogs must be on leash at all times. Owners will be charged \$50.00 whenever their dog is found loose. These monies will be donated to a local rescue society.
42. A Water Station to refill your own water bottles will be available on the grounds.
